1. Pay by phone at 903-587-3334
  
2. Appear at the Leonard Municipal Court, located at City Hall - 111 W. Collin Street, Leonard, Texas. Hours of operation are 8 a.m. to 5 p.m. Monday through Friday with special extended hours on Wednesday, March 3, from 8 a.m. to 6:30 p.m.
  
3. Place payment in after-hours drop box located behind City Hall. This drop box is yellow and is marked "WATER BILLS ONLY."
